**ORDER:**

In the Government letter first read above, the Government have ordered that the privileges offered by the State Government to the Minority Communities namely Muslims, Christians, Sikhs, Buddhists and Zoroastrians (Parsis) are extended to be members of the Jain Community, residing in the State of Tamil Nadu.

2. In the letter second read above, the State Minorities Commission Member has requested the Government to issue Jain Community Certificate for availing benefits from the State and Central Governments.

3. In the letter third read above, the Additional Chief Secretary/ Commissioner of Revenue Administration has sent a proforma for Minority Community Certificate and also requested to clarify in specific terms as to which are the privileges offered by the State Government to the Jain Community is entitled so that the Tahsildars would be in a position to issue Minority community Certificates without any ambiguity.

4. The proposal of the Additional Chief Secretary/ Commissioner of Revenue Administration was examined in detail and it is clarified that the privileges now offered to the other Minority Communities i.e. Muslims, Christians, Sikhs, Buddhists and Parsis by way of Scholarships by the Government of India through the Commissioner of Minorities Welfare and Loan schemes by the National Minorities Development and Finance Corporation through Tamil Nadu Minorities Economic Development Corporation are now extended to the Jain Community residing in Tamil Nadu.

5. The Government has decided to accept the proposal of the Additional Chief Secretary/ Commissioner of Revenue Administration and hereby orders in the format prescribed for issue of certificate to Jain Religious Minority as annexed to this order.

6. The Additional Chief Secretary/ Commissioner of Revenue Administration is requested to give necessary instructions to all District Collectors to issue the Jain Religious Minority Certificate after due verification as per the format prescribed by the Government.

7. This order issues with the concurrence of Backward Classes, Most Backward Classes & Minorities Welfare Department vide its U.O. No.1905/MWRU/2015, dated 12.03.2015.
